General Dealer Agreement

In anticipation of a friendly, profitable, and lasting relationship, I ask you to review the facts regarding All Auto Financial.

- 1. The purpose of this agreement is to set fourth rules that will govern the purchase of acceptable paper by All Auto Financial Corp.
- **2. Assignment.** Dealer's assignment of Paper (the 'Assignments' and each an "Assignment") to All Auto Financial. Shall be without recourse except as provide in this agreement or in the agreements. The assignment shall be required to be acceptable to All Auto Financial corp. in its sole discretion.
- **3. Dealer Representation and warranties.** in order to induce All Auto Financial. to purchase Paper, Dealer Represent and warrants that:
- (A) Each item of Paper, related information and documents provided to All Auto Financial Corp. are genuine, contain the valid signatures of buyers and guarantors, correctly state the terms of the transaction, and are true and accurate in every material respect.
- **(B)** All signer had the legal capacity to contract at the time of their signature.
- **(C)** The goods and services are truly and accurately described in the Paper and have delivered to, together with a copy of the Paper, and willingly accepted by owner
- **(D)** The down payments have been paid in full by buyer without help from the dealer and were actually paid in cash or merchandise received in trade as shown.
- **(E)** Title to the goods and services is vested in buyer under the paper, and All Auto Financial. Holds a valid first lien upon the goods.
- **(F)** Title to the goods and services is not branded, nor is the required to branded as rebuilt, salvage, flood or other designation which may decrease the market of value of the goods and services. If so, Dealer agrees to repurchase the contract.
- **(G)** Dealer possesses all of the requisite state and other jurisdictional licenses required to engage in its business an to sell the Paper to All Auto Financial Corp.
- (H) No payments have yet been received on the balance of the purchase price as set forth in the Paper.
- (I) No representations and warranties have been made to buyer other than those contained in the Paper and the Paper represent the entire agreement of Buyer and Dealer.
- (J) Such steps as are necessary to perfect All Auto Financial Corp. security interest in the goods have been taken.
- **(K)** Dealer has furnished All Auto Financial Corp. with copies of all disclosure required to be given to Buyer under applicable law in connection with sale of the goods and services that are the subject of each Paper, and such disclosures and the matter in which they are given conform to all applicable laws and regulations.
- (L) The sales transaction and the Paper arising from such sale comply with all application federal, state, and local laws and regulation.
- **4. Title & insurance.** Prior to purchasing the contract All Auto Financial requires that lien recorded. Dealer shall be responsible of making sure that All Auto Financial Corp. is listed in the insurance and registry as lien holder
